| BACKGROUND: | The client provided an undocumented descendant chart of Benedicht Reichenbach and Maria Raaflaub with six children: Maria Elisabeth (b. 24 August 1836, Switzerland) Emanuel Carl (b. 21 August 1837, Switzerland) Johann Friedrich (b. 21 March 1843, Russia) Arnold Benedicht (b. 22 May 1847, Russia) Samuel Alfred (b. 29 March 1850, Saanan, Switzerland); married Carrie (maiden name not included in pedigree chart) John Albert (b. 18 February 1854, Rowsburg, Ohio); married Mabel J. Newcomer. They had one child: Marie (b. 27 August 1891) Documents: 1860 United States Census, Benedict Reichenbach, Ashland, Ohio 1907 death record of a Frederick Reichenbach in Stark County, Ohio Samuel's marriage record to Carrie Horton, Butler County, Nebraska Ulrich Reichenbach marriage record to Fannie Ellis (determined during research to not belong to client's family) |

SUMMARY OF FINDINGS

Christian, Matilda and Ulrich A. Reichenbach were born to parents, Benedict Reichenbach and Susannah Catharine Schopfer. The 1900 United States Census shows this Benedict as having arrived in the United States in 1881. These children are not the children or grandchildren of Benedict Reichenbach, who was born in 1809 in Switzerland and died in 1900 in Butler County, Nebraska. Benedict (1809-1900) had a son, Alfred Benedict Reichenbach, who was born on 18 April 1847 in Kiev, Russia in present-day Ukraine.¹ He died on 5 September 1870 in Holmes County, Ohio without issue.² Joseph C. Plumer was appointed administrator of his estate and his father, Benedict, purchased most of his personal estate items.³

A descending genealogy of five generations beginning with Benedict Reichenbach (1809-1900) and Marie Emma Raaflaab (born between 1835 and 1837 and died between 1880 and 1891) is provided in this report. Twenty-seven descendants, plus spouses are identified; the majority primarily descend from Emanuel Charles Reichenbach (Benedict¹) and his wife, Wilhelmina Frisch. Aside from Charles, the only other child of Benedict to have issue was John Albert Reichenbach and his wife Mabel Jennie Newcomer. Their child, Marie H. Reichenbach, never married and her line closed with her death in 1991.

This is an international descending genealogy; therefore, the generational numbering system begins with Generation a-1 for the immigrant ancestor. Generation b-2 depicts the immigrating children of Benedict and Maria. Generations 3-5 represent generations who were solely born in the United States.

Plus signs before names depict individuals who have descendants who are carried forward in the descriptions in the next generation in the descending genealogy.

LIMITATIONS

This round of research was limited to fifteen hours at double the fee due to the client's request to be placed earlier in the research calendar; however, the researcher delivered about 30 hours of research, equivalent to the regular fee.

1. Benedict^{*a*-1} Reichenbach was born in Switzerland on 15 October 1809⁴ (Attachment 2) and died in Rising City, Butler County, Nebraska on 30 December 1900.⁵(Attachments 7 and 8) He married Marie Emma Raaflaub, likely in Switzerland, prior to the birth of their first known child, Elizabeth, who was born sometime between 1835 and 1837 in Switzerland.⁶ On 15 September 1852, he immigrated to the United States through the port of New York with his wife and three children.⁷ (Attachment 1) Benedict married

2. Maria Raaflaub was born about 1812 in Switzerland;⁸ she died between 1880 and 1891, probably in Ashland County, Ohio, before her husband sold his Rowsburg, Ashland County, Ohio property and followed their two youngest sons to Nebraska.⁹(1880 U.S. Census and Attachments 6 and 9)

A biographical sketch of the two youngest sons of Benedict and Maria reports that the ancestral lines of the Reichenbach family originated in Germany. This sketch and a summarized obituary of Benedict provide the following insights into Benedict's life before immigration to the United States:

"During the Thirty Years' war they were driven from that country and took refuge in Switzerland. They were Protestants in religious faith...In early life, [Benedict] was an artilleryman in the Swiss army and was a messmate of Louis Napoleon during the latter's exile."¹⁰ "His reminiscences of his army life as an artillerist with Emperor Napoleon are entertaining. He was a tanner, having established the largest tannery in Russia, introducing the French method of tanning. He enjoyed the patronage of Czar Nicholas, who was present at the opening of his tannery."¹¹ He operated extensive tanneries in both France and Russia, but lost his property in the latter country during Kossuth's revolution for having lent aid to the Poles during this Hungarian revolution. His immense property interests totaled about \$250,000 and were confiscated by the czar.¹² (Attachments 2 and 8)

Upon arrival in the United States, Benedict and Maria made their home in Ashland County, Ohio where Benedict acquired five city lots and established a tannery in Rowsburg of Perry Township:¹³ (Attachments 3-5)




Figure 2. Location of Benedict Reichenbach's Tannery in Rowsburg, Perry Township, Ashland County, Ohio14

Between 1880 and 1891, Benedict left Rowsburg and resettled in Butler County, Nebraska. He sold the property in Ohio after his departure.¹⁵ (1880 U.S. Census and Attachments 6 and 9)

Benedict and Maria had six known children. Their birth locations document their lifetime migration from Switzerland through Russia and to the United States:

- ELIZA REICHENBACH, born between 1835 and 1837 in Switzerland;¹⁶ died without known marriage or issue on 5 June 1906 in Douglas or Butler County, Nebraska.¹⁷ (Attachment 92) The United States Census records from 1860 through 1900 suggest that she resided with her parents or her younger brother for entire life.¹⁸ She was not listed on the 1880 defective, delinquent or disabled schedules of the census.¹⁹
- + 3 ii. EMANUEL^{b-2} CARL "CHARLES" REICHENBACH, born about 1837 in Switzerland; died 21 December 1872 in Jefferson, Marion County, Texas. He married at Harrisburg, Dauphin County, Pennsylvania, Wilhelmina Frisch.
 - 4 iii. JOHANN FRIEDRICH REICHENBACH, born 17 February 1843 at Alte Krym in the Crimea on the Black Sea in then-Russia, present day Ukraine; he was baptized at the Lutheran Church in Zürichtal, Feodocia, Tavrida, Russia (present-day Ukraine).²⁰ (Attachment 10) He died on 5 December 1843 in Odessa, Russia, present-day Ukraine where he was also buried.²¹

- iv. ARNOLD BENEDICT REICHENBACH, born 18 April 1847 in Kiev, Russia in present-day Ukraine;²² (Attachment 34) died 5 September 1870 in Holmes County, Ohio.²³ (Attachment 12)
 "Mr. Arnold Reichenbach, one of the proprietors of the Doncaster House in Orrville, died on Monday evening [5 September 1870] of typhoid fever. Mr. Reichenbach was formerly of Wooster, where we have known him for years, to be a young man of fair promise. His business qualities were good. For several years, he was with Mr. John Zimmerman & Co."²⁴ A search of deeds in Holmes County failed to produce any evidence of his proprietorship, shared or otherwise, of the Doncaster House or any other real property in the county.²⁵ The Doncaster House was a hotel across the street from the Passenger depot of the railroad station Orrville, Ohio. Several railroads serviced the area.²⁶ (Attachment 14) He appears to have never married and had no issue. Joseph C. Plumer was appointed administrator of his estate and his father, Benedict, purchased most of his personal estate items.²⁷(Attachments 11 and 13)
- 6 v. SAMUEL ALFRED REICHENBACH, born in Russia or Switzerland on or about 15 February 1850;²⁸ died 27 May 1939 in Rising City, Butler County, Nebraska.²⁹ On 28 November 1889, Samuel married Carrie M. Horton in Rising City, Butler County.³⁰ She was born in about 1870 in Michigan to Minerva Horton and a yet unknown father. In 1880, Minerva was a widowed schoolteacher in Butler County, Nebraska and listed New York as her place of birth. She had no other children living in the household.³¹ Samuel Alfred built a

strong early foundation with his brother, John Albert Reichenbach, which supported him and his wife for the rest of their lives. (See Early Life of Reichenbach Brothers) With such success, however, also came challenges – particularly in legal battles. (Attachment 27)

David A. Minick versus Samuel A. Reichenbach, in his role at Rising City Bank concerning title and property to land on which Minick failed to meet mortgage requirements. In about 1891, Minick took out a mortgage for his farm from Aetna; he turned over the mortgage to the bank where Samuel Reichenbach was a director. Minick then became financially embarrassed. Samuel Reichenbach, in his leadership role at the bank, convinced Minick to sign over the property to the bank to resolve his debt. However, Samuel assured Minick that he could later purchase his property back from the bank, if desired. Minick agreed. With Minick's knowledge, Samuel paid the taxes on and made improvements to the property. After several years, Minick approached Samuel at the bank and agreed to relinquish any future claim to the farm if the bank would execute a smaller loan to him to finance a smaller farm. Samuel agreed and loaned Minick the money for the smaller farm. Over the course of twenty years, the original farm – which Minick had relinquished – tripled in value. Minick then approached the bank to purchase the property back, but Samuel refused because he had already made a deal to relinquish his right to the property. Minick claimed that he had suffered two strokes and didn't have the mental capacity to know what he was doing when he relinquished title. The Supreme Court of Nebraska ruled in favor of Samuel Reichenbach on three points: (1) Samuel paid the taxes on the property for 10-20 years; (2) Samuel made improvements on the property with the full knowledge of David Minick; (3) Minick had managed to take out a smaller loan and run a farm successfully over the ensuing years—without any evidence of mental capacity issues.³²

Samuel and Carrie had no known children. Samuel's obituary listed only his wife, his brother John, and his niece Marie Reichenbach (John Albert's daughter). (Attachments **30 and 31**)When Samuel's estate was settled in 1940 – a year after his death – it totaled \$548,344. (Attachments **32 and 33**) Taxes on the estate enriched the state assistance fund by \$3,552 and Butler County received \$6,581 in inheritance taxes from the probate.³³




Figure 3. Estate of Samuel A. Reichenbach enriches state and county coffers.³⁴

- Wife's cousins: Maud Rickman, Herbert Catlin, Ada Phillips, John Catlin, Ella Laliky, Gene Catlin, Lottie Way, Harvey Hill, Erma Irwin, M. V. Hill, Oscar Hill, Alice Hill, Laura Burgess Hill, Philip Burgess, Ada Bowman Lucas, Amy Jones, Nine Burgess and Libby Burgess Hill.
- Wilhelma [Wilhelmina] Thompson, the daughter of his deceased brother Emanuel Charles Reichenbach. In a codicil dated 26 March 1935, Samuel revoked the provisions and gifts to Wilhelm[in]a Thompson without explanation.
- Mari Reichenbach, the daughter of his brother J. A. Reichenbach

Early Life of Reichenbach Brothers

Samuel Alfred and John Albert Reichenbach perhaps had the closest relationship amongst any of the siblings. When Alfred arrived in New York with his parents in 1852, he was only two years old. Two years after his arrival, his younger brother, John Albert was born at the new family home in Ohio. After the two boys were reared and educated in Ohio, they set their eyes on new adventures and migrated westward to Nebraska in 1877.³⁶ By this date, the railway was well established all the way into Nebraska.³⁷ While the young men may have taken a train to Chicago, a primary rail hub, and transferred to another line taking them to Nebraska, that wasn't the chosen mode of transportation. *The Lincoln Herald* covered the death of John's daughter Marie in 1992 and claimed the two young men migrated to Nebraska by covered wagon.³⁸

They first located in Saunders County, west of Omaha, north of Lincoln and just east of Rising City. For the first five years, they lived life close to the land – first in farming for two years, then lumber for three. Then, they moved to Rising City in Butler County where they established Rising City Bank. "In 1888 they opened the Bank of Pittsburg at Pittsburg, Boone County, Nebraska, and in 1897, they organized the Reichenbach Land & Trust Company, with \$50,000 capital. The company owned large tracts of land in Butler and Polk Counties and [was considered] one of the most reliable concerns of the kind in the state."³⁹ Both brothers were successful businessmen, and their early ventures were joint efforts. (Attachments 2, 39 and 40)

24) He married on 19 December 1865, **Wilhelmina Frisch**, daughter of Henry and Wilhelmina Frisch, at Harrisburg, Dauphin County, Pennsylvania.⁴¹ (Attachment 49) She was born on 6 February 1839 in Pennsylvania and died on 19 February 1883 in Harrisburg, Dauphin County, Pennsylvania.⁴² (Find A Grave and Attachment 52)

E. C. or E. Charles, as he was commonly referred to in the United States, did not arrive with his family members in 1852. His arrival record in the United States remains undiscovered, but a naturalization record was apparently recorded for him in Holmes County, Ohio in 1859 – the same county where his brother Arnold's obituary was published in 1870.⁴³ Following in his father's military footsteps, Charles joined B Company, 23rd Ohio Infantry during the Civil War. His prowess with managing the supply lines led to a rapid progression in the ranks. On 19 May 1863, he resigned his commission at First Lieutenant in the Ohio Volunteers–with a personal proclamation to be "totally incompetent to serve as an officer of the line, not knowing anything about military tactics and being unable to march on foot." On 10 June 1863, he accepted a commission as Assistant Quartermaster at the regimental or depot level in the rank of Captain and transferred to Harrisburg, Dauphin County, Pennsylvania. By the end of the war, he was promoted to the rank of Brevet Major for acknowledgement of his competence – a rank with the honor of the title, Major, but without the associated pay. On 13 July 1866, he was honorably mustered out of service.⁴⁴ (Attachments 15 and 38) In the immediate months after the discharge of his duties, he took a leadership role on the Dauphin County Soldiers' Monument Association to recognize the contributions of soldiers: (Attachment 19)

Upon transition to civilian life, Charles made an equally indelible mark on his community in Harrisburg. He established a legal practice and was subsequently appointed an Alderman of the Second Ward, Harrisburg: (Attachments 20 and 21)




Figure 5. Advertisement, E. C. Reichenbach, Attorney-At-Law⁴⁶

On 13 May 1869, an advertisement in the *Harrisburg Telegraph* listed his Third Street law practice location as for sale. (Attachment 23) Apply to "B. Frisch" suggests that Charles may have been out of town during the sale. B. Frish may have been Barnhart Frisch, his wife's brother, who was the head of household in the 1870 U.S. Census when Wilhelmina was listed in the Frisch home in the apparent absence of husband and with her daughter. (Attachment 50) In 1872, a simple death announcement appeared in the same newspaper that listed the sale of his property three years prior. No probate record was located in Dauphin County.




Figure 7. Death Announcement of E. C. Reichenbach⁴⁸

Wilhelmina Reichenbach apparently continued to live with her mother and brother through 1880.⁴⁹ (Attachment 51) On 19 February 1883, she died at age 44 – leaving 15-year-old Wilhelmina Reichenbach with her 68-year-old grandmother, Wilhelmina Frisch. (Attachment 52)

E. Charles and Wilhelmina had only one known child:

7. John Albert^{b-2} Reichenbach (Benedict^{*a*-1}), born in February 1854 in Rowsburg, Perry Township, Ashland County, Ohio;⁵⁰ died 27 January 1941 in Omaha, Douglas County, Nebraska.⁵¹ John Albert married on 16 January 1890 in Rising City, Butler County, Nebraska, **Mabel Jennie Newcomer**.⁵² Jennie was the apparent daughter of Thomas W. and Julia A. Newcomer.⁵³ She died on 7 June 1949 in Douglas County, Nebraska.⁵⁴

After John and his brother established Rising City Bank, Pittsburgh Bank and the Reichenbach Land Company, John enjoyed the privilege of expansive leadership positions in multiple financial

- In 1929, he became Vice President of Lincoln Liberty Life Insurance Company.⁵⁷ (Attachment 43)
- In 1930, he was re-elected as Vice President of the Lincoln Trust Company.⁵⁸ (Attachment 42)

In 1933, John made a significant philanthropic contribution to the Salvation Army when he gifted to them a building in Lincoln, Nebraska. The charitable organization had previously owned the building, known as the Havelock property, but had to relinquish title due to lack of funds. The building was worth about \$3,000 in 1933; today, the estimated \$3,000 would be worth about \$62,699. John's contribution was recognized in an event led by Salvation Army Major Charles E. Ward at the Lincoln Hotel.⁵⁹ (Attachment 45)

Like his brother, legal battles followed. In perhaps the largest of his lifetime, forty-four bondholders sued John, his brother and the Reichenbach Land Company for \$86,000 in damages. Reichenbach Land Company and Lincoln Safe Deposit Company, where John served on the Board of Directors, sold bonds on a mortgage that was never transferred to the persons who made the mortgage on the land and claimed to own it. Instead, the majority of the land remained in the name of Reichenbach Land Company and Lincoln Safe Deposit Company, the latter of which had since filed bankruptcy leaving the bondholders without full compensation.⁶⁰ (Attachment 29)

On a social note, John, his wife and daughter enjoyed an extended tour of the United States in 1917: (Attachment 41)

John and his family made their home in Lincoln, Nebraska until the last four years of his life when they moved to Omaha.⁶² (See obituary in possession of the client) A request for his will from the county clerk in Douglas County produced a negative result. They had only one child:

9 i. MARIE H. REICHENBACH, born 26 August 1891 in Rising City, Butler County, Nebraska; died 3 December 1991 in Omaha, Douglas County, Nebraska.⁶³ According to her attorney at the time of her death, Raymond Crossman, Jr. reported to *The Lincoln Star* that she "never married, didn't socialize much, didn't have many friends, seldom traveled and seemed satisfied with keeping to herself."⁶⁴

However, this wasn't true of her early life or of her philanthropic interests. In 1925, she was elected to the position of Corresponding Secretary of the Lincoln Women's Club, an organization that took interest in civic matters of the city.⁶⁵ (Attachment 47) This position may have come her way due to her father's position in society or due to her participation in other social circles. Of note, in 1915, she became a member of the Daughters of the American Revolution, a lineage society granting membership to women who could prove they were a descendant of a Revolutionary War soldier. Her membership was gained through her maternal ancestor as follows:




Figure 11. Lineage to a Revolutionary War Soldier, Marie H. Reichenbach, National Society Daughters of the American Revolution⁶⁶

During her lifetime, Marie donated thousands of dollars to "the Omaha Symphony, the Omaha Community Playhouse and the Duchesne Academy and also supported the opera and ballet. She gave about \$100,000 to Joslyn Art Museum." She made annual contributions to the Tabitha Nursing Home, which her parents started. Most of her estate came from farms owned by her father in Nebraska, Kansas and Iowa. Overall, when she died, her estate totaled well over \$6 million. She left \$2 million each to the Tabitha Nursing Home, the University of Nebraska Medical Center and Boys Town in Omaha. Smaller contributions were made to the American Red Cross, the Salvation Army and a scholarship fund for Omaha high school students.⁶⁷ A request for her will from Douglas County, Nebraska resulted in the Clerk's response that the will had been withdrawn from their records in 2017. She reportedly also left \$10,000 each to three unidentified cousins who lived outside Nebraska.⁶⁸ Given her only paternal cousin, Wilhelmina Reichenbach, died in 1964, these gifts were likely left for surviving maternal cousins.

Generation 3, Descending, Grandchildren:

Wilhelmina³ Reichenbach (Emanuel^{b-2}, Benedict^{a-1}) born 20 February 1868 in Harrisburg, Dauphin County, Pennsylvania;⁶⁹ died 4 May 1964 in Oakmont, Allegheny County, Pennsylvania.⁷⁰ (Attachment **58**) Wilhelmina married in Dauphin County on 21 November 1889, **Walter L. Thompson**, the son of Osborne Thompson and Nancy Barkley.⁷¹ (Attachment **53**) He was born on 1 July 1859 in South Carolina.⁷² He died on 9 January 1927 at home at 306 S. Home Avenue, Avalon, Allegheny County, Pennsylvania.⁷³ (Attachment **57**)

At the time of their marriage, Walter was employed by the Steelton Flour Mill Company. By 1900, Walter and Mina had moved to Chicago, Cook County, Illinois where he was a traveling salesman.⁷⁴ (**Attachment 54**) They owned their home, which was under mortgage, at 584 Kenwood Place. In about 1907, they returned to Pennsylvania and resided in Pittsburgh. A search for them at home in the 1910 United States Census produced a negative result. By 1920, they had returned to Pennsylvania and

Fifteen-year-old Andrew immigrated to the United States on a journey through the port of New York as a joiner bound for Braddock, Pennsylvania.⁸⁵ (Attachment 93) His journey led him and his later wife, Jane, on an incredible lifetime of adventures as his education and military service led him to manage many art galleries and to become a Monuments Man during World War II, focused on reclaiming stolen artworks during the war and seeking to return them to their rightful owners: (Attachments 80 and 81)

eventually saving enough money to pay for his own tuition at the University of Pittsburgh. There, he earned a Bachelor's degree in 1927 and a Master's degree in Medieval Studies in 1933.

Ritchie's natural talent and self-determination earned him a fellowship to study at the Courtauld Institute of Art in London, where he completed a Ph.D. in English Medieval Art in 1935. Upon his return to the United States, he began work as a research assistant and lecturer at the Frick Collection in New York. He also gave lectures at New York University and Johns Hopkins University. In 1942 he was appointed Director of the Albright Art Gallery (today, the Albright-Knox Gallery) in Buffalo, New York.

In mid-1945 Ritchie was selected by the Roberts Commission to assist the MFAA with restitution of objects looted from Austria. Taking a leave of absence from the Albright Gallery, he travelled to Vienna, where he served at Headquarters of United States Forces in Austria (USFA) alongside Monuments Men Lt. Col. Ernest T. DeWald, Lt. Cdr. Perry Cott, and Lt. Frederick Hartt. In November he was selected as the successor to Monuments Man Maj. L. Bancel LaFarge as Chief of the MFAA Section for the United States Forces, European Theater (USFET) in Austria. As the representative of the USFA at the Munich Central Collecting Point, some of his most memorable accomplishments include personally escorting Jan Vermeer's The Artist's Studio ("the Czernin Vermeer") to Vienna in a private railroad car, and accompanying the Holy Roman regalia from Nuremberg to Vienna on board a C-47 transport plane.

In the years following his return to the United States, Ritchie served in influential positions at some of America's most prominent cultural institutions. After departing the Albright Gallery in 1949, he became Director of the Painting and Sculpture Department at the Museum of Modern Art in New York. In 1957 he succeeded former Monuments Man Lamont Moore as Director of the Yale University Art Gallery. His most notable acquisition was that of Paul Mellon's impressive collection of British art, which he used as the basis for a new museum, the Yale Center for British Studies (today, the Yale Center for British Art). In addition to commissioning famed architect Louis Kahn for the museum's innovative building, Ritchie continued to expand the collection. In 1970 he was the first American citizen given an honorary Ph.D. from the Royal College of Arts in London. Following his retirement from Yale in 1971, he spent one year as Robert Sterling Clark Professor of Art History at Williams College in Massachusetts.

Andrew Ritchie died in Sharon, Connecticut on August 12, 1978. To this day, the Yale Center for British Art and the Yale University Art Gallery jointly sponsor the annual Andrew C. Ritchie Lecture in tribute to his transformative contributions.⁸⁶

Probably the most comprehensive view of his life is provided in his obituary: (Attachment 68)

Walter L. Thompson, Jr., of Bellevue, assistant sale[s] manager for the Jones and Laughlin Steel Corporation in the Pittsburgh district, died Wednesday morning of a heart attack as he was driving to his office.

Mr. Thompson began his career with Jones and Laughlin in 1916 as a clerk in the order department, later working a year in the Midand [Midland?] plant of the Crucible Steel Company as a mill hand. In 1919 he was promoted to salesman for the Pittsburgh district, and in 1936 was made assistant district sales manager.

Born in Germantown, Pa., in 1892, Mr. Thompson later moved to Pittsburgh with his family. He attended Shadyside Academy and Cascadilla Prep School in Ithaca, N. Y.

He served two and one-half years with the Motor Transport Division in World War I and was discharged with the rank of captain.

Mr. Thompson was a member of Dallas Lodge, F. and A. M., and the Pittsburgh Athletic Association.

Services will be held Friday at 3 p.m. at his home. Burial will be announced later.⁹⁵

The horror of World War I and the massive loss of life among allied troops is most certainly exemplified by the Walter's rapid promotion record – which, no doubt, was due to the mass casualties suffered by his fellow soldiers: (Attachment 66)

- From 14 April through 24 April 1917 (seven days): Walter was a newly minted Private in the Army serving with the 18th Pennsylvania Infantry.⁹⁶
- On 24 April 1917, just a week into his service, he was promoted to Regimental Supply Sergeant.⁹⁷
 - On or about 5 August 1917, he and/or his unit was reassigned to the 111th Infantry, 28th Division.⁹⁸
- On 9 July 1918 of the following year, Sergeant Thompson received a direct commission as a Second Lieutenant in the Quartermaster Corps; on the same date, he was reassigned to Motor Supply Train 420.⁹⁹
- On 12 September 1918, a mere two months after his direct commission, he was promoted to First Lieutenant where he served until his discharge on 5 March 1919. He completed outprocessing from the military at Camp Dix, New Jersey.¹⁰⁰




Figure 19. Wedding Story of Lt. J. G. Walter Lowry "Zip" Thompson III and Clara Jane Starrett¹⁰⁹

"RICHMOND [Vermont]– Warren Lazell Beeken died at his home in Richmond [Vermont] on Sunday, June 20, 2004, of cancer.

Warren had lived in the Burlington area since 1965, when he moved here with his family from Hanover, H.H., to start a gastroenterology unit at the University of Vermont College of Medicine.

Warren was born in Beaver, Pa., on May 6, 1926, the younger son of a tool steel salesman and an artist.

After graduating from nearby Shadyside Academy in 1944, Warren joined the Navy. He served as a medic stateside through the conclusion of the war. Warren then attended Haverford College, after which he went to medical school at Temple University in Philadelphia.

While in medical school, Warren met his wife-to-be, Ruth, the sister of a friend, on a blind date. They married in Hamilton, Ontario, on August 11, 1950, and headed north honeymoon on the first of many canoe camping trips in the Temagami region of northern Ontario.

Warren began his career in academic medicine with his residency at the Mary Hitchcock Hospital in Hanover, where Warren and Ruth's sons Bruce and David were born in 1953 and 1955, respectively. A third son, Tim, was born in 1959 during a stint in Seattle, Wash.

At UVM, Warren's practice focused on inflammatory bowel disease and Crohn's Disease. He recently described his contribution to Crohn's research as ruling out numerous possible factors in the disease – he viewed his work as covering the "error" side of the trial-and-error of medical research. Warren eventually was appointed to a full professorship and chaired his department. He recruited many past and present members of the gastroenterology unit before retiring in the mid-1990s and was generally known for his service to the medical school as well as to his patients.

When Warren wasn't at the hospital or his lab, he mostly was in the woods. In winter it was cross-country skiing. Warren made skiing a three-season sport, all with trail clearing in the fall and skiing in the winter and spring until the snowmelt got the point that he couldn't see from one lingering patch of snow to the next. His wife, children, friends, visiting professors, medical students, prospective recruits to the GI unit – all were conscripted to pitch in during whichever season it happened to be.

From the early days helping work on the Madonna Vasa ski trail from Smuggler's Notch to Underhill, Warren went on to scout and clear what became a heavily skied trail from Stevensville up through the Devil's Dishpan and down to the Trapp trails. With Warren and Ruth's move from Burlington to Richmond in the mid-190s, Warren turned his attention to Camel's Hump. The rugged trail he scouted around the mountain is skied every March as the Camel's Hump Challenge fund-raiser for medical charities.

In summer, Warren found in canoe camping some consolation for the lack of snow. Warren and Ruth celebrated nearly half of their 53 wedding anniversaries in the Temagami region where they had honeymooned, often in the company of their family and friends.

Warren became very involved in community service in Richmond. He was an active member of the Richmond Land Trust. With Ruth, he served as a guide for events at the Old Round Church. Warren served on the Town Planning Commission. Warren spent many days working on the Winooski Rivershore Preserve walking path.

Following his retirement from UVM, Warren devoted himself to caring for Ruth, who has Alzheimer's Disease. In addition, Warren served as the head of the Vermont Chapter of the National Cancer Society for a time following his retirement. Also during this period, Warren returned to the practice of building wooden sleighs and other toys for neighborhood children and his grandchildren, as he had done for his own children in earlier years.

Warren loved to be out in the woods – in any conditions, at any time of year, whether on skis, clearing trail, working on the Rivershore path, cutting and splitting wood, paddling his canoe, or even portaging it waist-deep in mud with the mosquitoes swarming. And he always loved sharing the experience with whomever he could muster to join him.

In addition to his wife Ruth, Warren leaves three sons and their families: Bruce, Sara and Josie of Shelburne; David and Atmo of Woodbury; and Tim, Jane and Sam of New York City. Warren also leaves a brother, Alfred, of Pittsburgh, and his family; and many friends, including Emily Lee and Mary Gundel, whose extraordinary devotion meant so much to Warren and his family in the last weeks of his life. We all miss him very much.

A memorial will be held at the Old Round Church in Richmond at 2 p.m. on Saturday, June 26, followed by a gathering at the Richmond Free Library. Donations in lieu of flowers may be made to the Richmond Land Trust, P.O. Box 605, Richmond, VT 05477."¹²⁴
